WORKING FAMILIES GARBAGE

The misnamed Working Families Party (WFP) was legally formed in 1998. It is currently on ballot line Row E. It is a more radical successor to the old disenfranchised New York State Liberal Party.

The WFP is a New York City dominated labor coalition made up of aggressive union members. Its ideological principals are very liberal, even extreme! It is in favor of granting the right to vote to non-American citizens. The WFP is in favor of issuing drivers licenses to illegal aliens. It favors legislation "forcing" public agencies and private businesses to accept IDs from foreign consulates rather than NY issued photo IDs. It believes that the criminal drug laws are not important. All of the WFP's other ideological principles, pursuant to its website, and otherwise, are very radical, even un-American.

The WFP apparently uses a shadowy field operations company, Data and Field Services (DFS), to illegally steer union resources to some of its endorsed candidates. The WFP and DFS are indistinguishable since they share office space and personnel. Some of the WFP candidates pay huge sums of money to the WFP for its endorsement and for DFS's aggressive campaign operations. The WFP is currently under investigation for violating N.Y.S. campaign laws.

In the 2007 County Legislature election, the State WFP and/or DFS, became active in opposing a Monroe County Legislator in the 6th L.D. They sent unemployed union members from throughout New York into that Legislative District. These out of County residents "aggressively" campaigned door to door against the incumbent. They made false allegations. They attempted to intimidate the voters. As one voter said; "The union representatives appeared to be a bunch of thugs. They lied to me. They harassed me into not voting for a good guy and a great Legislator." As a result of this inappropriate conduct, the Legislator lost. The County lost a valuable member of the Monroe County Legislature due to the aggressive wrongful actions of WFP thugs.

The WFP is a wholly owned subsidiary of ACORN Bertha Lewis is co-chairman of the State WFP and executive director of ACORN, NY. Both entities share office space and personnel, ACORN, DFS and the WFP appear to be criminal enterprises who deserve the

current investigations and their eventual convictions.

The WFP is basically a collection of spending interests disguised as a political party. It has a fiscally reckless tax and spend agenda. It forced Albany, in the most recent budget (2009-10), to increase state spending by \$14 Billion and to incur a huge budget deficit. This despite a severe recession?

The WFP is a radical political party. It has crossed over the fringe of the political spectrum. Any candidate who takes its endorsement (Dan Maloney, WFP candidate for Greece Supervisor) apparently shares its questionable aggressive tactics and its extreme principles. Hopefully this year the voters will look at those candidates endorsed by the un-American, thug dominated, WFP which is controlled by the criminal enterprise known as ACORN, and appropriately vote for their well qualified, principled opponents on the Conservative ballot line, Row D.

MASSA: AN ARROGANT, CONDESCENDING, OUT OF CONTROL, PELOSI LIBERAL

Eric J. Massa (NY - 29 C.D.) represents all or part of the following Monroe County Towns: Brighton, Chili, Gates, Henrietta, Mendon, Penfield, Perinton, Pittsford and Rush. He also represents seven Southern Tier Counties. Congressman Massa is a freshman Democrat now residing in Corning. He is an opportunistic "carpet bagger" who moved into the district only to run for Congress. He has never lived or worked in Monroe County.

On Saturday, May 16th, 2009 at Mr. Massa's request I met with him for approximately two hours. During said luncheon the Congressman talked incessantly about..... himself. He bragged about being in the Oval Office with a very "tall" President Obama. A tall socialist? He kept referring, in the third person, to "the Congressman from New York" (himself). Massa's geographic Congressional District is very large. However, Mr. Massa's ego is even bigger. It is huge!

During our May 16th meeting, apparently because Massa wanted the Conservative endorsement, he invited me at least four times to visit him in Washington. I could observe the Marine Corps Drill Team (I am a Vietnam Marine Corp veteran). Other politicians have told me Massa invited them to

Washington to land in a Navy Jet on an aircraft carrier and/or to eat in the Congressional Dining room. Who would pay for the visits? The taxpayers? Obviously, I declined his politically motivated taxpayer expensive invitations.

Congressman Massa is apparently attempting to campaign as "a military hero". One observer described his 24 year Navy military career as his being; "a political desk jockey with few substantial accomplishments". The closest he came to a real military conflict was his T.V. set. Bizarrely, Massa often wears his modest, standard Military Medals and Ribbons on his business suit while attending campaign fund-raisers?

Mr. Massa voted for the failed Obama stimulus bill (\$787 Billion, with millions of jobs lost) and for the Obama budget (\$3.6 Trillion, with an eventual obscene National deficit). Therefore, he voted to advance socialism. He voted to recklessly mortgage our children's and grandchildren's future. Massa voted for the "cash for clunkers" program. There, your richer neighbor can use your tax money and add to a huge budget deficit to buy a foreign car. Like most Liberals, Massa thinks money spent by the government (\$3 Billion for clunkers) is "free". The Congressman is a strong supporter of, and voted for, radical Liberal Nancy "the CIA lied to me" Pelosi.

In August of this year, Massa said: "I will vote adamantly against the interest of my district and for OBAMA HEALTH CARE" (HR-3200) (single payer, rationing, higher costs, cuts in Medicare, budget deficit, inefficient socialized medicine, etc). RENAISSANCE SQUARE: The Mayor and Rochester City Council Act "STUPIDLY" Against Rochester

The Renaissance Square project (hereinafter RS) was the largest and most ambitious public works project in the history of Monroe County. It was composed of three parts: a Transit Center, a Monroe Community College city campus and an Arts Center. RS was to be located on East Main Street between North Clinton Avenue and St. Paul Street. That location was selected by Rochester Elected Officials ten years ago.

RS was a \$230 Million (now lost) project with over \$100 Million in Federal funding already secured. Most of the remaining funding was guaranteed. \$24 Million has already been spent on that project. County Executive Maggie Brooks (Rep.-Cons.) was the main proponent for RS with no political benefit for her (Rochester is very Democratic). In Maggie's vision RS would be the diamond in the landscape of Monroe County. It turned out she believed more in downtown Rochester development than the Rochester Officials.

RS would have resulted in 3,700 new construction jobs (city residents). 300 new long term jobs (city residents) would have been created by that project. 4,200 new M.C.C. students (city residents) would have revitalized a deteriorated downtown. The current North Clinton Avenue location is mostly abandoned and boarded up. It's owners owe \$350,000 in back city taxes. That location has serious and costly asbestos problems (\$7 Million). Those issues remain for private development. They would have been cured by RS There will be no future substantial private development at the RS site.

On July 23rd, 2009 Democratic Mayor Duffy and the all Democratic City Council voted unexpectedly and abruptly to kill the RS project (deadline, changes). This was after 24 Public hearings were held on RS since 2004. Mayor Duffy as a member of the "Main and Clinton Local Development Corporation" for 3 1/2 years voted six times to advance, and to spend at least \$17 Million, on the RS project.

Maggie wanted RS to be the jewel of Monroe County. Now because of the actions of the Mayor and City Council that location is a lump of coal. Visitors to Rochester, leaving the Hyatt, the Convention Center and the Clarion who look East on Main Street will see an abandoned ghost town. Why was RS

killed? The charitable answer is that the Mayor and city council in an ego driven, political, vote simply didn't understand the long term damage to Rochester by their rejection of the R.S project.

The Mayor has hung an "unwelcome sign" on downtown Rochester. RBTL and others will now leave. PATEC and other companies will probably not want to have their Corporate Headquarters next to a slum.

The Rochester Leaders acted very "stupidly" to terminate a downtown Rochester project which would have been very beneficial to Rochester residents and to the City of Rochester. Very regrettable! Very sad! Pathetic!

ELECTION 2009

This year's election is fascinating and rather unpredictable. The key battle ground should be for control of the Monroe County Legislature. The targeted races are in Henrietta, Gates and Perinton. Currently the Republicans hold a 15-14 majority in the Legislature. A Democratic controlled County Legislature would not be good for Maggie, the Republican-Conservative coalition or for the citizens of Monroe County. A Democratic majority would be dominated by the radical Rochester Democrats whose ideological philosophy is contrary to that of the majority of the

Monroe County citizens.

The turnout in Rochester should be very low this year. [No City contests] The Police Department problems in Greece could cut into the traditional Republican Conservative majority. The County Court contest should be aggressively hard fought and close. Sheriff O'Flynn, Justice Fisher and Judge Renzi should electorally crush their comparatively unqualified opponents. Greece Supervisor Auberger should defeat his Working Families, ACORN, radical, unqualified opponent. The vast majority of our 106 well-qualified Conservatively endorsed candidates will win. Election 2009 should be very interesting.
