OBAMA: A Terrible President!

President Obama has acted unlawfully. ARTICLE II, SECTION 3 of our Constitution states, "THE PRESIDENT SHALL FAITHFULLY EXECUTE THE LAW." ERIC HOLDER: A Discriminatory, Unlawful, Liberal, Partisan Politician

Eric Himpton Holder, Jr. was born in New York City in 1951. His father was from the Caribbean country of Barbados. Holder graduated from Columbia University (1973-B.A.) and from Columbia Law School (1976-J.D.). While at Columbia, Holder was an active member of the Student Afro-American Society (SAAS). That organization, with Holder in a leadership role, engaged in illegal occupations of University Offices (ROTC, Dean's office, etc.). SAAS was a supporter of the Black Panthers who were at that time charged with plotting to blow up a police station, department stores, railroad tracks, and the New York Botanical Gardens.

In January 2001, Holder as a Deputy Attorney General was instrumental in facilitating many of President Clinton's questionable last minute pardons. Holder facilitated pardons for members of the Weather Underground Organization, an entity which advocated the violent overthrow of the U.S. government. Clinton's most infamous pardon was for Marc Rich who had fled to Iran and renounced his American citizenship. Mr. Rich, a billionaire, was charged with 51 counts of racketeering, wire fraud, tax fraud, tax evasion, and illegal transactions with Iran. His wife, Denise, was a large contributor to Clinton's campaign. The pardon appeared to have at least a "whiff" of bribery. After the Rich pardon, Clinton credited Holder's recommendation as his justification.

In 2009, Holder was appointed U.S. Attorney General by President Obama. He quickly said; "The American people on race are essentially a nation of cowards" (2-17-09). On Election Day 2008, members of the New Black Panther Party intimidated white voters with racial slurs and threats of physical violence at a Philadelphia inner city polling place. These activities were captured on video. This was an obvious violation of Section 11(B) of the Voting Rights Act of 1965. The Bush Administration commenced a Civil Rights lawsuit. The defendant failed to answer and defaulted. However, the Holder Justice Department then inexplicitly, abruptly dropped the civil rights charges against the New Black Panthers.

Barack "Hussein" Obama refuses to acknowledge Terrorist Attacks and Islamic extremism. When Nidal Hasan

murdered 13 fellow soldiers (and injured 34) at "Fort Hood" after this he screamed "God is great" in Arabic. Holder's Justice Department labeled the incident as only "workplace violence"? This is bizarre and very unfair to the victims and their families (no purple hearts, combat pay, disability, civil lawsuits, etc.). The "Underwear Bomber" was not a terrorist? Holder referred to the failed airplane bombing attempt and other acts of terror only as "man caused disasters". Holder in 2004 (Padilla Amicus brief), and as Attorney General, has argued that alleged Islamic terrorists have a right to be treated as criminal defendants (Miranda rights, etc.) and not as enemy combatants (including 911 mas-termind, KSM).

In January 2012, the House of Representatives in a bi-partisan vote (255-67) held Holder in "contempt". This was the first time in the history of Congress that a sitting Attorney General was found in contempt. This drastic action was a result of Holder's activities in the "Fast & Furious" gun running scandal. There, a Border Patrol Agent, Brian Terry, was murdered with a gun from said program. Holder committed perjury before a Congressional Committee. He obstructed justice by not responding to a valid House subpoena in that matter. If you or I did what Holder did, we would be in jail!

On May 15, 2013, in sworn testimony before the house Judiciary Committee in regard to the "potential" prosecution of the press for the disclosure of material Holder said: "... that is not something I have ever been involved in, heard of or would think would be wise policy" (emphasis added). Said statement is unequivocal! It turned out to be a lie under oath; PERJURY! Subsequent admitted facts show that Holder personally signed the affidavit for the search warrant in regard to Fox News reporter James Rosen's emails, etc. He discussed it. He approved it. That affidavit labeled Rosen a co-conspirator and said he may flee. The affidavit was submitted to three Judges by Holder (Judge shopping) until Holder found a friendly Justice. Holder swore the affidavit was true! Our Chief Law Enforcement Officer openly, obviously, and notoriously committed PERJURY on May 15, 2013.

Holder has been the most partisan Attorney General since Nixon's John

Mitchell. Holder sees his post as primarily political. He uses the law and his prestigious position as the Nation's Chief Law Enforcement Officer to accomplish and enforce Obama's Liberal policy agenda. Holder is Obama's close friend, agent, and his ideological alter-ego. As Attorney General, Holder has interpreted the Constitution and the Law to curtail 2nd Amendment Rights. He has attacked State Voter Identification Laws. He has brought lawsuits in favor of Abortion Rights and against pro-life protections. Holder, as our Chief Law Enforcement Officer, has improperly taken a lead "progressive" political role on many issues. Holder is using his office to advance Obama's Liberal politics. It is not about the rule of law or the pursuit of Justice. For Holder, it is all about Obama's politics. He has obstructed justice and committed perjury. America deserves so much better than Eric Holder as our Attorney General.

Food Stamps Gone Wild!

Food Stamps, the Supplemental Nutritional Assistance Program (SNAP) is designed to provide groceries to the poor. This includes "junk food" and luxury foods (lobster, etc.). Food stamps were initiated by L.B.J in 1964 as part of his "war on poverty". Despite its name SNAP is not a nutritional program. It does not alleviate hunger. Under Obama's "stimulus plan" and pursuant to his aggressive dependency advertising, Obama has increased food stamp usage dramatically. Currently, there are almost 50 million Americans on food stamps (up from 26 million in 2007). The cost of SNAP is currently over \$80 billion dollars (up from \$35 billion in 2007). Food stamps have an "income test" not an assets test. Therefore, multi-millionaires with no recent income can be on SNAP (Leroy Fick, a \$2 million lottery winner).

The food stamp program is permeated by FRAUD. It is a magnet for abuse. The funds and policy behind SNAP come from the United States Department of Agriculture (U.S.D.A). However, the enforcement for food stamps abuse is controlled by local governments. Those prosecutors have not made SNAP violations a priority. The most common fraud in regard to food stamps is called "trafficking". That is where SNAP benefits are exchanged for cash. Then, that money is used for alcohol, prostitution, drugs, the lottery, etc. Since the food stamps are in the form of an Electronic Benefit Transfer (E.B.T) card, fraud is easy and confidential. In Oregon, it has been estimated that there is over a 50% trafficking fraud rate for the homeless. In N.Y.C, SNAP recipients have obtained food and mailed it in large containers to relatives in Jamaica, Haiti, and the Dominican Republic. Many jail inmates obtain food stamps benefits at a non-prison address.

Under Obama, almost all food stamp applications are approved with no investigation. Then, they are automatically renewed. Democratic candidates like those in the recent N.Y.C Democratic Mayoral primary, pandered to SNAP recipients to get their votes. Obama and the other Liberals like food stamps since they increase the size and power of government. We need to care for the truly needy. However, those who can work should not receive taxpayer's money in the form of food

stamps. Hard work, self reliance, individualism, and pride are compromised by Obama's progressive policy of unneeded dependence on food stamps. The truly needy deserve a safety net. However, Obama has made the food stamp program an unnecessary, overly large, fraudulent hammock.

OBAMACARE: A Train Wreck!

On April 17, 2013, Democratic Senator, Max Baucus, Chairman of the Senate Finance Committee said in regard to the implementation of ObamaCare: "I just see a huge train wreck coming". Baucus was a key player in the passage of said law. During the debate on said Bill, Nancy Pelosi said: "we will have to pass it to see what is in it". The more that the American people have learned about ObamaCare the more they dislike it. It is very expensive, complicated, and unfair. It deprives a patient of his own doctor, and it will result in shortages and delays in medical care. Obama has called his government healthcare law his signature Legislative accomplishment.
