
## MARK ASSINI TO KEYNOTE 53<sup>RD</sup> ANNUAL CONSERVATIVE DINNER

## "HANDS UP, DON'T SHOOT" A Dangerous Liberal Lie. It Never Happened!

President Obama and a vast left wing conspiracy (the liberal Media, Academia, Hollywood, some Unions leaders, many minorities, many elitist, etc.) have wrongly created and perpetuated a fraud on the American people as to what really happened to Michael Brown in Ferguson, Missouri on August 9, 2014. Their theme is that a racist white Police Officer, Darren Wilson, unlawfully and unnecessarily killed an "innocent" black teenager. That false story has resulted in "die ins" and protests of "hands up, don't shoot" (U of R, N.B.A. games, The View, Congressional Black Caucus, etc.). Ridiculous! There were riots, arsons, and looting as a result of the left's untrue narrative. Thanks to the media frenzy and lynch mob mentality, Ferguson is still a very

emotional and controversial subject. It shouldn't be!

Now 9 months after Ferguson, it is clear that the police officers' actions were necessary, justified, and appropriate. They were in self-defense. The extensive physical evidence and the voluminous credible testimony make the continued actions and comments by the Liberals on Ferguson false and even ridiculous. The actual story of Ferguson is set forth below:

On August 9, 2014, Michael Brown a 315 lb 18 year old committed a strong arm robbery at the Ferguson Market and Liquor Store in suburban St. Louis. He assaulted a store employee on the way out (both crimes captured on a store security videotape). He and his

*criminal accomplice and eventual perjurer, Dorian Johnson, then walked down the middle of Canfield Drive disrupting traffic. Ferguson Police Officer Darren Wilson instructed Brown to walk on the sidewalk; He failed to comply with that request.*

*Then, Brown reached inside the police car and punched Wilson three times on his right cheek (photographs and hospital records). He attempted to take Wilson's weapon leaving DNA & blood on his gun (hospital reports, medical examiner report, and photos). During the struggle, 2 shots from Wilson's gun were fired into the inside front police door. Brown was slightly wounded in his thumb from*

# HILLARY: Good Poll Numbers. A Terrible Record!

*approximately 6" (Medical Examiner report). Brown left. However, he shortly returned and violently charged at Wilson getting to within 8" of the Officer before he was killed.*

The above story is partially based on the Grand Jury testimony (2000+ pages) of over 60 witnesses. Officer Wilson's Grand Jury testimony of the above is also verified by the extensive physical evidence: medical examiner report, 3 autopsy reports by 3 forensic experts (including 1 paid for by Brown's family), DNA, blood samples, shell casing locations, ballistic reports, photos, video, etc. There is absolutely NO doubt as to how and why Michael Brown was shot by Officer Wilson. Self-Defense!

Brown did not have his hands up, and he was not trying to surrender. He was not shot in the back as alleged by his criminal accomplice Dorian Johnson (medical examiner report, ballistic reports, photos and credible testimony). The 3 autopsy reports indicate that Brown was under the influence of T.H.C. (marijuana) and over twice the drug legal limit for driving. Brown was carrying a bag of marijuana.

President Obama sent 3 high ranking Administration Officials to Brown's funeral. Why? He received the Ferguson protestors at the White House many times. Why? ## ELECTION 2015

This year there will be 129 local public offices up for election. The Monroe County Conservative Party will endorse approximately 105 well-qualified candidates. We will select our candidates from enrolled Conservatives, Republicans and Democrats. Our County-wide endorsements will include: County Executive, District Attorney, 4 Supreme Court Justices, and a Family Court Judge. All 29 Monroe County Legislators are up for election this year and most of the Town officials (Supervisors, Town board members, Town Judges, etc.) will be on the ballot. The Monroe County Conservative Party will endorse the very best conservatively oriented candidates in 2015. Since there is not a Presidential, Gubernatorial or Mayoral election this year, voter turnout will be down (especially in the City). This should lead to a very good election year for the Monroe County Conservative Party. We will play a constructive and pivotal role ("margins of victory") in Election 2015.

## ELECTION 2014

Last year's election was very good for the Monroe County Conservative Party. We endorsed 33 candidates for public office and we had 27 winners. Row C was the "margin of victory" for Rob Astorino defeating Governor Cuomo in Monroe County. Surrogate Court Judge John M. Owens received 21,216 votes on our line. This with only 8,056 enrolled Conservatives. Therefore, a 263% Conservative voter turnout with a 43% general voter turnout. Statewide we easily kept Row C with Rob Astorino receiving 250,634 votes. Our line was the "margin of victory" for three State Senators. Therefore, a Republican State Senate will protect our citizens from the corrupt Liberal Democrats from New York City. In Election 2014 the Conservative Line, Row C, was strong, consistent, and pivotal.
