## WHERE WE STAND

# SOME DEMOCRATS ENGAGE IN MONEY LAUNDERING!

In September 2014 New York City Mayor de Blasio and 160 potential donors had a meeting at a Manhattan Law Firm to discuss how to turn the State Senate to Democratic control. This obviously would help NYC. He urged contributors to donate to 3 upstate Democratic County Committees (Monroe, Ulster, and Putnam). He then said the committees should give that money to specific local Democratic Senate candidates. This scheme would avoid campaign contribution limits which applied to Senate Campaigns (\$11,000) but not to County political committees.

Therefore, in October of 2014 three large NYC unions (CWA, Teachers Union, and Builders Workers Union) donated \$225,000 to the Monroe County Democratic Party (Dave Garretson, Chairman). That Committee then immediately gave \$218,633 to the campaign of State Senator Ted O'Brien (Jamie Romeo, Campaign Chairwoman). It would have been illegal for the unions to directly contribute said sums to Mr. O'Brien's campaign. The NYS Board of Elections investigated and issued a report which found "considerable evidence of wrongdoing" in de Blasio's scheme to avoid the campaign contributions limit law. The U.S. Attorney and the FBI are investigating the above money laundering.

# OBAMACARE'S DEATH SPIRAL!

In 2010 President Obama, Senator Reid, Speaker Pelosi and their liberal allies lied, cheated and used political bribes to enact the Affordable Care Act (Obamacare). They claimed that you could keep your own Doctor, that health care premiums would be reasonably controlled, that millions of the uninsured would get coverage and that health care options would increase. In order to get our endorsed candidates on the ballot (Row C) the law requires we obtain at least 5% of the enrolled Conservatives in an election unit to sign our **Nominating Petitions**. This year we had 48 petition passers who obtained over 700 signatures (Charlie LaGaipa alone got 190 signatures). The Monroe County Conservative Party is a loyal, efficient grassroots organization.
