SHERIFF O'FLYNN:

A HARDWORKING, EFFICIENT, PROFESSIONAL ADMINISTRATOR.

One of the more interesting election contests this year is the race between Sheriff Patrick O'Flynn and Todd Baxter for Monroe County Sheriff. Patrick has been our sheriff for the last 16 years. Before that he was the Undersheriff for Andy Meloni for many years. He is a much decorated veteran of the Sheriff's Department. **Patrick** supervises over 1100 uniformed and civilian employees. He manages a budget of over \$130 million. Patrick is a law and order public safety professional! There has been no scandals or problems during our sheriff's tenure. He is a charming, good guy. Mr. Baxter is apparently currently unemployed? He is an enrolled Republican running as a Democrat. A political opportunist? Baxter is supported by the liberalprogressive Democrats in Monroe County and by the unfair, uninformed radio whacko Bob Loserberry. Our great Sheriff vs an unemployed political opportunist? It should be no contest!

COOK RE-ELECTED

On Monday, September 25, 2017, Tom Cook was re-elected Chairman of the Monroe County Conservative Party. This is his 20th two year term which may be a state record for longevity. Of course, Tom was 5 years old when he was first elected (conservative humor)! Also elected on the 25th was talented, loval, volunteer, working, hard Conservative member Executive Committee. The Monroe County Conservative Party is a respected, important, pivotal and constructive force in Monroe County politics. We intend to continue said tradition!

NITTI: NOT A "GOOD" JUDGE!

He is one of a few incumbent judges not re-endorsed by the MCCP. Four separate independent political parties, based on his failed judicial record, no longer support Nitti!

During the last 38 years the Monroe County Conservative Party has endorsed and helped to elect hundreds of very good Judicial candidates. This includes Judges in State Supreme Court, County Court, Family Court, Surrogate's Court, City Court, Town Court and Village Court. Before we make our endorsement, or re-endorsement, we obtain input from prosecutors, police, defense attorneys, probation officers, litigants, clerks, judges, and others. As a partial result of our input, many consider the Monroe County Judiciary among the best in New York State. We previously supported Gino Nitti for Greece Town Judge (before he developed a bad judicial record). This year, and before, we received many complaints regarding Nitti's conduct. Credible sources told us he DID NOT **SHOW UP** for regular court hearings and/or trials (no reason given) and he was otherwise LATE for court (average time 30 minutes). Several police officers told us he was very hard to find as an "on call arraigning judge". Once he kept a felon and the police waiting for hours so he could "finish watching an NBA TV game". Other cops referred to him as the "missing judge". Often Nitti comes off the Bench to conduct non-emergency **PERSONAL BUSINESS** (phone calls, etc.) leaving as many as 70 individuals waiting in court for up to an hour. It was alleged that he was often unprepared for Court and that he didn't work hard as a judge. LOW ENERGY! (5 inputting individuals described him as "lazy.") It was said that Nitti failed to show to officiate at several WEDDINGS. Nitti was told (June 5th, 2017) he was not being re-endorsed and that he would have to **PASS PETITIONS** and obtain signatures if he wanted to be on the ballot. He and his supporters obtained 0 signatures (low energy). Each of his 4 opponents, or their supporters, obtained 2947 petition signatures. Nitti then filed a FRIVOLOUS LAWSUIT which was laughed out of court unanimously by the Appellate Division and the Court of Appeals. The Democratic Chairwoman then misled the Democratic petition signers by putting Nitti on the Democratic line for Town Judge without their knowledge and consent.

We had our 55th Annual Dinner on Friday, May 12, 2017. Nitti attended and sat at the Greece table. He remained for the entire event and paid extra for the VIP reception. Our non endorsement of Nitti was based on his poor record as a Judge. It had nothing to do with the Conservative dinner which he attended. On July 24, 2017 there was a front page article in the D&C above the fold which said: PETTY POLITICS LED TO REMOVAL OF NITTI FROM BALLOT. It stated or strongly implied that we didn't endorse Nitti because he didn't attend our dinner? The FALSE allegations, therein, came from Nitti with help from Gannett who we have virtually driven out of Judicial politics (Matt Nafus, etc.) Are the reasons set forth above "petty politics?" Hardly! Nitti's name was not removed from the ballot. He did not, pursuant to Election Law, have a life term. Unfortunately, Nitti is a very poor Judge. In 38 years we have re-endorsed approximately 440 judges. Nitti is one of the few incumbent Judges we didn't re-endorse! Four separate political parties (Republican, Conservative, Independence and Reform), based on his record, did not re-endorse Nitti. We have the right and obligation to not re-endorse a very bad Judge. Incumbent judges are very hard to beat electorally. Therefore, some Democrats and the D&C are now strongly supporting Nitti despite his bad judicial record. The easy thing to do would have been for us to reendorse Nitti. The right thing was to protect our citizens by rejecting a very poor Judge and endorsing and helping to elect very good Judges. Please vote for David M. Barry, Brett Granville, Shannon O'Keefe Pero and Vince Campbell on election day. We must continue our tradition of electing the very best Judicial Candidates.

our Executive Committee for 34 years has submitted his resignation. He is a brilliant lawyer with our county's largest law firm. His legal advice to our party was invaluable. / An interesting election contest this year is the race in the 10th County Legislative District (northern Pittsford, southern E.R. and one district in Brighton). We are supporting JASON ROSENBERG. He is a small business entrepreneur who believes in creating jobs and stable taxes.
